

 - c. ½ yards

 - b. You cannot trade a ½ yard for two ¼ yard pieces or vice versa.
 - c. The trade must be "like for like".

OLD BUSINESS:

Finance Committee Job Description Change in By-Laws:

As we discussed at the February meeting, and was printed in the most recent Plain Print, we have a conflict in the Job Description for the Finance Committee as it appears in our bylaws in Article 7, #3.

The proposed change would read:

The Finance Committee shall consist of four appointed members, the Treasurer-elect, and the Treasurer, who shall serve as chair. Members of the Finance Committee shall serve a two-year term, with two new members being appointed each year by the Executive Board. In the event a member cannot complete the term, a member will be appointed by the Executive Board to fill the unexpired term. The duty of this committee shall be to prepare the budget for presentation to the Guild at the March meeting, to be adopted at the April meeting.

Motion to accept the proposed bylaw change as was just read by Cindy Weyers. Second by Rosalind Carr. Motion passed.

\$500 Policy

At the February meeting we proposed an amendment to the bylaws pertaining to our policy that says the Board may spend up to \$500. For any amount over that, the

expenditure must be voted upon by the Guild.

We also discussed the idea of monies being donated to groups outside the Guild. The question arose as to what would happen if the Board decided to donate money to a group and the majority of the Guild was not in agreement. The Guild would not have any way to change this.

When Kate was proofing the Plain Print, she realized that a mistake was made as to where this should be inserted into the bylaws.

The Board would like to propose an amendment to our bylaws to be called Article 12 to read as follows:

The Board is authorized to spend monies up to \$500 on Guild expenses. Amounts over \$500 must be presented to the Guild and put to a vote of the membership.

Any proposal to donate money to any group outside of LQG must first be presented to the Board. The Board would then present the proposal at a LQG meeting and put it to a vote of the membership.

Again, a bylaw change, according to Article 11, needs to be presented at one meeting, published in the Plain Print, and voted on by the membership at the following meeting. We will vote on this bylaw change at the April meeting.

"Cut-Up" Friendship Blocks

Martha Lane and Donna Welte have been brain-storming to come up with a new "twist" in the monthly *Friendship Blocks*. This idea is simple and won't require a pattern. Just follow these instructions.

This is a continuation from the blocks that were made last month. For those who won, you already have the starting stage to these next steps.



Shaded 9-Patch

Trim the half square blocks to 7½". Cut the block vertically and horizontally at 2½" intervals resulting in nine (9) 2½" squares. Three (3) of these will be half square triangle units and six (6) squares.




Arrange your newly cut 2½" pieces in a pleasing 9-patch arrangement making sure that dark squares are on one diagonal half and the light squares are on the opposite diagonal half. Sew your pieces together into a shaded 9-patch block. These blocks can be arranged just as you would arrange log cabin blocks.

For the April 9 meeting

Half-Square Triangles in 2 sizes











Put them right sides together and draw a diagonal line on the lighter square. Stitch a ¼" away on each side of the drawn diagonal line.





Cut on the drawn diagonal line and press open. You will have 2 half-square triangles. DO NOT TRIM. **Turn in at the April 9 meeting.**


